1 Dates

Applications open: Friday 31 July 2020Applications close: 4pm, 28 August 2020

2 Purpose

Bundaberg Regional Council invites artists residing in the Bundaberg region to submit their EOI to be considered for the *Together Again* public project. The opportunity is for temporary art installations to be placed at the Moncrieff Entertainment Centre and Bundaberg Regional Art Gallery ('Venues'.)

EOIs to be considered would include but not be limited to; painting, drawing, photography, collage, digital works and other mediums not mentioned here. This is an excellent chance for local emerging and established artists to showcase their artwork widely throughout the region and gain recognition of their work further afield.

Works will be chosen to be shown in external poster frames at the venues. One single work will be chosen as the hero image for the 2021 Arts Bundaberg program promoting Galleries, Moncrieff and Libraries programs. <u>Link to the Arts Bundaberg 2020 Program here</u>.

The artist/s creating the work selected for the Arts Bundaberg program image will be paid a fee of \$500 as a license fee for the use of the image from commissioning until 31 December 2021. The work remains the copyright of the artist but a limitation will be placed on the use of the image by Council for the required time.

Artists of all forms and genres will be eligible but the final works must be able to be presented in a two-dimensional form on a poster, flyer or book cover.

3 Objective

Artists will be asked to create works in response to the theme *Together Again*. Response can be interpretive and may consider the following.

- To imagine the future beyond the isolation and limitations COVID-19
- Highlighting the importance of community and connectedness
- Hope for the future
- A celebration of reconnecting

One piece only will be selected and offered a commission of \$500. Commissioned art will be used primarily as the cover of the upcoming Arts Bundaberg Season Program. This program will be reproduced up to, but not limited to, 25,000 impressions, with the understanding that there will be no further fee paid per impression by the 'Venues'.





4 Project Budget

The total budget for this project is \$500 (inc GST). Costs for printing of larger works for exhibit will be covered internally.

5 Process

You are invited to submit up to two works for consideration in this showcase. Collaborative works from two or more makers are welcome. We are looking for new works made after July 2020.

Images of artworks submitted with the EOI must be a minimum of 300dpi, that will easily allow the artwork to be cropped or reproduced at high resolution. Largest size for reproduction would measure 720 w x 1020 h mm. Artwork is submitted with the knowledge that the artwork may be reproduced digitally in part or whole and displayed at Moncrieff Entertainment Centre and/or Bundaberg Regional Art Gallery, using internal and external spaces at the 'Venue's' discretion.

Failure to provide requested will render the application 'Failure to Submit' and the application will not be considered. By submitting an EOI you authorise the 'Venue's' to display artworks as described in 3. Objective.
